

Pupils at Gatehouse Chambers are supported from their very first day. Whilst pupillage is, of course, an assessment, it is very much a learning experience as well and Chambers recognises this.

Gatehouse Chambers offers a range of specialisms and Chambers encourages pupils to obtain experience in all its core practice areas. However, pupillage is flexible and Gatehouse Chambers aims to accommodate where pupils express an interest in particular practice areas.

Chambers provides a strong training programme where pupils are assessed on both written work and advocacy. Pupils receive regular feedback throughout the process and, in my view, are given the best opportunity to succeed.

There is no doubt that pupillage is a tough year but Gatehouse Chambers made my experience as comfortable and supportive as possible. During the course of the year, I moved to three different supervisors and whilst I was set on practising in property law, rotating supervisors exposed me to different practice areas I had never studied before including Private Client, which now forms around 50% of my practice.

Gatehouse Chambers also places considerable focus on the pastoral side of pupillage with help and support available whenever you need it from a designated pastoral supervisor. I had the misfortune of dealing with a family emergency during the last few months of pupillage and was understandably concerned about how this would impact on my tenancy decision. However, everyone in chambers was incredibly supportive and provided me with the support I needed to take time off and return to chambers confident that it would not affect my tenancy decision.

Everyone knows that pupillage is in many ways a year-long interview, but Gatehouse Chambers' open-door policy and network of junior practitioners means that you will always be able to stress-test ideas and approaches without any fear of being marked down. There are also multiple learning opportunities in the form of the two advocacy assessments, in which members who sit as judges provide constructive, detailed feedback in a friendly environment.

In each of your three seats during pupillage you are exposed to a different supervisor's practice. The range of work you experience during the 12 months is therefore very broad and means, that as you start to specialise, you are able to make a genuinely informed decision as to practice areas.

In each of your three seats you are allocated two wingers who specialise in a practice area that interests you. You are expected to complete three pieces of formally-assessed work for them (in addition to completing as many pieces as you can for other members). The system is such that you are never kept in the dark about your performance and have a steady flow of feedback throughout the year, allowing adjustments to be made on a continuing basis.

Pupillage is both an assessment of that potential and a learning experience. You're given regular feedback from your supervisor and secondary supervisors ("wingers") to let you know where you stand, but you're also given space to make mistakes and grow. For example, during our first six, a member took time each week to refresh us on the principles of different parts of the Civil Procedure Rules – something which has proven useful to me in practice.

Chambers' members take supporting their pupils seriously. Even non-supervisors took time to help with tricky issues I faced during my first and second sixes. Further, the "open-door" policy was maintained even during lockdown – weekly catch-ups were organised and someone always had time for a virtual door-knock and video call!

During pupillage I gained experience in commercial, civil fraud, insolvency, construction, insurance and professional negligence work. Having a breadth of exposure to such high-quality work gave me the experience I needed to guide my future practice towards areas I hadn't previously considered.

Pupillage is the anchor for a successful career at the Bar; you will likely make mistakes, and encounter ethical conundrums along the way, but the professional and pastoral support in Chambers guides you through that challenging process.

I undertook a Third Six Pupillage with the Personal Injury and Clinical Negligence Team; I immediately felt at home with my team. I was able to nurture my existing skills and knowledge of this area, whilst uncovering new legal interests, including injuries arising out of terrorism, and workplace accidents. I also undertook paperwork for members outside of the team in areas such as Insurance. In terms of court work, I also undertook housing and commercial hearings for the first time. I have since fostered a specialism in Costs, which now constitutes over 40% of my practice, and I routinely appear in the Senior Courts Costs Office. As such, I now have a mixed civil practice with a focus on PI and Clinical Negligence. My practice has been shaped by rare opportunities in chambers; I find the variety of work stimulating, and I genuinely look forward to coming in each week.
